Dumpster is missing lids and must be replaced  
CODE REFERENCE: 64E-11.003(5). Garbage shall be disposed of to prevent vector harborage. Trash cans will be durable, cleanable, leak proof, insect and rodent resistant, and non-absorbent. Outside storage area shall be of a smooth, non-absorbent material and sloped to a drain.

**General Comments**

Went to conduct investigation 10:45 AM. First I investigated the back of kitchen and dumpster area. no evidence of rats observed however rat traps were out, dumpster lids are broken off, and wooden pallets were stacked up near the back kitchen door. I then investigated the kitchen and no evidence of rats observed, however new rat traps were out and kitchen manager claimed rat was caught earlier in the week. Kitchen back door has a slight crack and hole in them. Dumpster lid must be replaced, wooden pallets removed, and kitchen back door repaired. Conditions Unsatisfactory.
