**Directions:** The Elementary and Secondary Education Act of 1965 As Amended Through P.   - a. Each instructional paraprofessional must work under the direct supervision of a certified teacher;
  - b. No paraprofessional may provide tutoring during a time when a student would otherwise be receiving instruction from a teacher; and,
  - c. Paraprofessionals may be assigned only limited duties consistent with those assigned to similar personnel.
