Call to Order: A meeting of the Stanton College Preparatory School Advisory Council (SAC) was held in the Media Center at Stanton College Preparatory School on December 16, 2020. Kenyatta Register, Chair, called the meeting to order at 3:36 p.m. Catherine Spears recorded the minutes for the meeting.

Welcome: Ms. Majova-Seane welcomed all in attendance to the meeting. Participants introduced themselves.

Quorum: Seven of the nine Board member are present (five is required for voting) when the meeting was called to order therefore a quorum was formed.

Adoption of Agenda: The agenda was motioned, seconded, and unanimously approved as emailed. The board moved to have the meeting recorded for minutes purposes only. The motion passed at 3:40 p.m.

Minutes from Previous Meeting: Minutes from the November 18, 2020 meeting with requested corrections were motioned by Dave Karrmann and seconded by Elisabeth Marks for approval as a quorum was formed at this meeting. The unanimously approved minutes will be subsequently submitted to the District School Improvement Office.

85 Students are transferring from DVHR back to Brick and Mortar (B&M) for third quarter.

The school is continuously working to intervene/assistance students who are struggling academically and otherwise.
