SAC Meeting Minutes January 15, 2020

Attendance: Members present as noted on the attached sign-in sheet for Stanton College Preparatory School (hereinafter referred to as Stanton) School Advisory Council (SAC) and sign-in sheet for the community, stakeholders, including parents.

Call to Order: A meeting of the Stanton School Advisory Council was held in the Stanton Media Center on Wednesday, January 15, 2020. Chairperson Kenyatta Register called the meeting to order at approximately 3:32pm. Tessy Robbins, 2019-20 SAC Secretary recorded the minutes for the meeting.

Welcome: Mrs. Register welcomed all in attendance to the meeting.

Minutes from Previous Meeting: Minutes of the November 20, 2019, Stanton SAC meeting were reviewed and discussed. Approval of the minutes was not published due to the lack of quorum. They will be reconsidered at the February meeting.

Report from PTSA: Report from PTSA was provided by our PTSA Representative, Dawn Botkin.

- PTSA meeting was held yesterday, January 14, 2020
- PTSA membership: 1,079. Current enrolled student population is 1,575. We need another 181 more members are needed for Stanton to be considered 100% membership. Stanton PTSA will host a Chik Fil A Member drive in January.
- The student member parking spot drawing was completed. Luke Wilson, a junior, was awarded the monthly parking spot for January. Sarah Snelson, a senior awarded February spot.
- Tentative date for Campus Clean up is March 28, 2020.
- Winterfest went really well
- Blood drive numbers were down as anticipated. The next blood drive for this year school year will be in April.
- First tour date is January 16. Feeder Tour is February 7th.
- Next week is Spirit week
- January 25th is UNF Winter Formal Tickets on sale Friday for Seniors and next week for underclassmen. It is a Sadie Hawkins dance. Tickets are \$20.00 and will be sold during lunch and guest forms are available in the Activities Office.
- Grant applications were distributed in November. Ms. Betancourt asked for countertop ice maker. Ms. Riendeau requested dictionaries and both requests were purchased. Funding is still available.
- SG Tower resolutions has been discussed but the City Commissioners has not put one forth and doesn't plan to do so. The FCC can place these towers anywhere they wish to do so.

- Legislation: Legislators will be voting on HB 1079. Vicki Drake has prepared talking points outlining why a Board appointed superintendent is preferable to an elected superintendent.
- Reflections had 29 entries and at least one is going to state this year.
- February 22, 2020 will be Miss Stanton. Students can buy tickets 19th through the 21.

Old Business: The Stanton SAC Bylaws Amendments: A quorum was not present so approval could not be granted. The proposed amendment changes are

Article III – Section V - Peer election shall be used to select parent, education support staff, student and teacher members of the SAC. Such elections shall be held **at end of the school year**

for the upcoming school year such that the membership list of officers is ready to submit to the office of Instructional Research and Accountability as of October 1.

Article III Section 9 - Membership in the Stanton SAC shall be limited to no more than 20 voting members. The Stanton SAC is a sunshine organization and non-members are encouraged to attend meetings but may not vote. Voting in SAC meetings shall be limited to duly elected/appointed school board approved members.

Article V b) These officers shall be elected at the last meeting of the Stanton SAC school year for the upcoming school year provided notice of election has been served. Should a vacancy of an officer exist, elections will occur before October 1.
