Stanton College Preparatory School SAC Meeting Minutes March 22, 2023

Attendance: Members present as noted on the sign-in sheet for Stanton College Preparatory School (hereinafter referred to as Stanton) School Advisory Council (SAC) and sign-in sheet for the community, stakeholders, including parents.

Call to Order: A meeting of the Stanton College Preparatory School Advisory Council 7 held in the Stanton's Media Center on March 22, 2023. Kenyatta Register called the meeting to order at 3:30 p.m. Emmy Stone recorded for Catherine Spears to report the minutes for the meeting.

Welcome: Kenyatta Register welcomed all in attendance to the meeting. Participants introduced themselves.

Adoption of Agenda: The agenda was unanimously approved as printed. The motion passed at 3:35 p.m.

Quorum: Eight out of the twelve Elected Board members are present (seven is required for voting) therefore a quorum was formed. The current By-laws allows for a maximum of 30 Board members.

Minutes from Previous Meeting: Minutes from the February 16, 2023 meeting were motioned and seconded for approval as a quorum was formed at this meeting. The unanimously approved minutes will subsequently obtain submission to the District School Improvement Office.

Report from PTSA: PTSA representative, Cassia Burner, report was deferred due to her absence.

School Improvement Fund (SIF) Report: Ms. Register reported for Dave Karrmann reported that the balance as of March is \$2.37.

Principal's Report: A copy of the principal's report can be obtained from Principal Nongongoma Majova-Seane's office upon request.

The principal reported that based on the school data, the four steps goals for this year are as follows: ELA target is 94% goal with 153 focus students. History target is 98%. Math target is 90% with 78 focus students. Science target is 90% with 135 focus students. The focus students are level 1 and 2 students along with private school students without testing data. The Athletic Booster club is hosting a 5K run on March 25, 2023. She encouraged the board to support the event. A former Stanton graduate CPA firm in Orlando, FL has agreed to come to the school and host a Financial Literacy forum for the Seniors and then eventually will have one for the Junior and Sophomores.

Mr. Kerr reported that after the spring break, the school has ramped up on safety especially given the recent school shooting in TX. The school conducted random bag checks last week. The checks are performed weekly. The mud lot security was increased due to a random person on the parking premises. During Spring break six Theater students went to the Tampa Festival. Josh Phillip and Jacob Hewitt received superior ratings from the three judges. Senior, Noah Cook performed the monolog from Shakespeare to win superior rating with a perfect score from two of the judges. Junior Nicholas

Gas's won the Excellent award for Original Playwriting of "Who done did it?" The judges commended Senior Noah Hall for his playwriting receiving a perfect score for his ability to censor the script of Chris Rock's Broadway play day view.

Ms. Heggood reported on Senior class activities. Senior cap and gown orders should already taken place. The Seniors are planning to go back to their respective elementary schools to volunteer. The senior package that will be distributed to the students has extensive information about key dates, events, and exams dates. Looking for proctors for the exams. Prom is April 1, 2023.

Community Library Update: Chris, Public Library Representatives, reported that the parking issue is resolved and the Stanton students were not the problem. The city trash pick up was the cause of the parking issue. Seeking teen volunteers for the summer.
