Registering for Morning Care:

Please register your child using the following link. Make sure to select Oceanway Middle School, not Oceanway Elementary. Upon registration, the district will send the application to our Community Ed Director for approval. After approval, you can log into school cash online to pay the monthly fee.

Information:

Morning Care begins at 7:30 AM. Students can be dropped off at the front of the school to enter into the building at 7:30 AM or after. Students may not use the back entrance to the school. Students cannot be on campus before 7:30 AM. Students are not allowed to be on campus unsupervised prior to 7:30 AM. Drop off begins at 7:30 AM.

Students will go through the COVID-19 health screening and sign-in before entering morning care. If a student exhibits symptoms or has a fever, the student will be isolated and guardians will be asked to pick their student up immediately.

Students will report directly to the cafeteria for Morning Care and remain there until dismissed to begin the school day.

Students are required to wear a face mask during Morning Care and the school day. For Morning Care, students will need to bring something to work on or read. Students are not able to share materials and social distancing will be implemented.

Payments:

All payments for morning care are made electronically using School Cash online (<https://dcps.schoolcashonline.com/>).

*Please make sure to select Oceanway Middle, not Oceanway Elementary. Payment schedules can be found by clicking the link below.

- **The payment schedule is your OFFICIAL notice. Not having received a reminder that payments are due does not negate the Late Fee. Continual problems with late payments will result in your child not being allowed to remain in the Enrichment Program.**

Electronics: Students may use their own electronics with parent and Morning Care instructor permission. Electronics may only be used for school-related purposes. Instructors can designate if a student may or may not use their electronics. Parents and students will have to complete the electronics contract before usage in the program. Click here to do so

Program Rules:

We follow the Duval County Schools Code of Conduct.

Additionally, we have program rules and guidelines. If students cannot follow the rules of the program, parents will be notified. If problems persist or are severe, students will be removed from the program.

Students will be provided with information regarding the program on the first day enrolled and reminded daily.

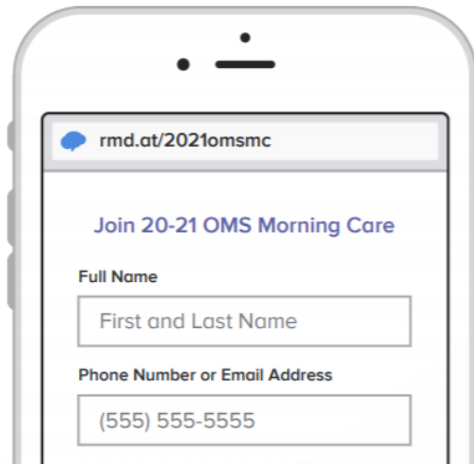

Follow the instructions to sign up for Remind. You'll be prompted to download the mobile app.

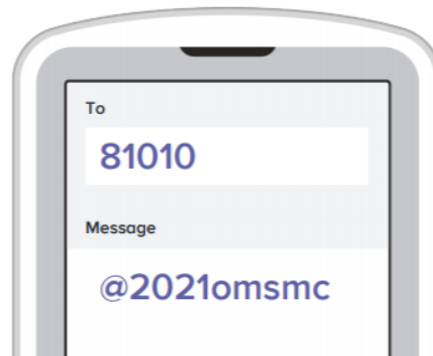


B If you don't have a smartphone, get text notifications.
