Parking is limited and all vehicles parked on the school property must be registered with Douglas Anderson. Parking without a decal is prohibited and any vehicle parked on campus without a valid decal is subject to towing at the owner's expense.

1. Decals will be available to seniors at orientation on **7/30/24 from 9:00-11:30am** on a first-come, first-serve basis for \$80. Any remaining spaces will then be sold to juniors **starting 8/12/24. Only seniors and juniors can purchase parking passes. Decals are NOT transferable.**
2. Students must have a copy of their current Florida or Georgia driver's license, insurance card, and car registration attached to this application along with payment to receive a permit.
3. All students must obtain a decal through the Dean's Office. **Decals must be displayed on the bottom left corner of the windshield (driver's side).**
4. Parking is strictly limited to the student's assigned numbered space only. **Violators are subject to towing at the owner's expense.**
5. Students are responsible for their own property left in the car. We recommend that students do not leave any valuables in their car.
6. Loitering in the parking lot at any time is prohibited. Students must leave their cars promptly upon arriving to school and leave the parking area after school by **4pm**. The only time cars should remain is if you are in a school sponsored event with a DCPS adult supervising.
7. **In accordance with Florida State Statutes, students who have more than 5 unexcused tardies or more than 5 unexcused absences per quarter, are subject to having their parking privileges revoked for the remainder of the school year.**
8. Loud music, speeding, and any form of reckless driving are prohibited.
9. **In accordance with the DCPS Student Code of Conduct, be advised that, upon reasonable suspicion, student lockers and other storage areas (including, but not limited to, MOTOR VEHICLES, book bags, pocketbooks, notebooks, pockets, personal electronic devices, etc.) may be searched. Additionally, school personnel are permitted to conduct administrative random searches for weapons and other contraband absent reasonable suspicion.**
10. Students are not allowed to go to their cars during school hours without approval from an Administrator.
11. **The student parking lots will be locked during the day from 9:00am to 3:25pm** for security purposes. Students arriving after this time should make other arrangements for parking.
12. Students will be assessed \$25.00 for a replacement decal.

Parking regulations are strictly enforced. It is considered a privilege to park on school grounds. Suspension from school and loss of parking privileges may result when violations occur.
