DOCUMENTS REQUIRED TO REGISTER VEHICLE

- 1) **Driver's License** – Copy of student's valid Class E driver's license (not a permit).
- 2) **Proof of Insurance** – Copy of proof of valid Florida insurance for this vehicle
- 3) **Vehicle Registration**— Copy of current Florida Vehicle Registration form
- 4) **CASH** - \$50.00

I understand that my driving privileges and parking permit can be revoked without a refund for violations of the parking regulations or as a result of Code of Conduct violations such as, but not limited to, leaving school without permission (alone or with another person). No decal will be replaced unless the old decal, or a large portion of it, is brought in to the Main Office. Vehicles parked on school property are under the jurisdiction of the school. The school reserves the right to search any vehicle if reasonable cause exists to do so. Students have full responsibility for the security of their vehicles and will make certain they are locked and their keys are not given to others. Students will be held responsible for any prohibited objects or substances, such as alcohol, drugs, and weapons that are found in their cars and will be subject to disciplinary action. Searches of vehicles may be conducted at any time there is reasonable cause to do so, with or without presence of the student. All students must park in the student parking lot only. **NO EXCEPTIONS.** Any violation of parking could result in a referral and/or fine (\$5 per violation). **IF YOUR PARKING PASS IS NOT VISIBLE OR YOU DO NOT HAVE A PARKING PASS AND YOU ARE PARKED ON CAMPUS, YOUR VEHICLE MAY BE TOWED.**

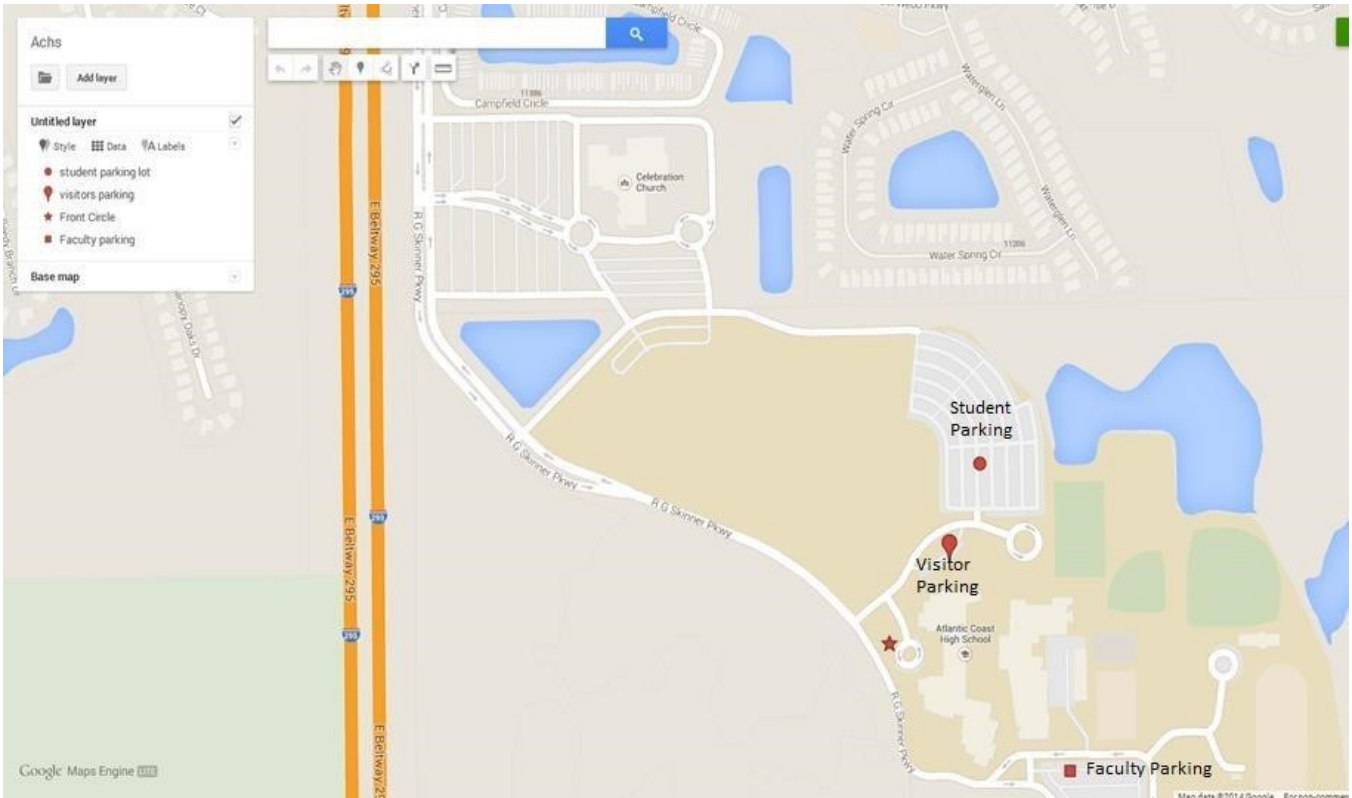
